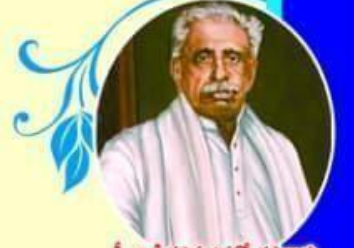

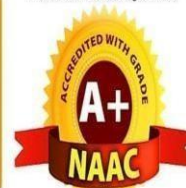

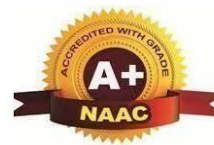

The Name of the Association shall be the "Govt. Arts College Old Students Alumni Association"

ARTICLES OF ASSOCIATION

AIMS & OBJECTIVES

- The Alumni Association is a voluntary service organization. Members are individuals who have studied in the institution and wish to contribute to its growth, inspired by National spirit.
- It should address issues faced by students, faculty, and staff, including infrastructure and administrative problems, to create a peaceful environment. The association should protect the institution's heritage, assets and support underprivileged and meritorious students through scholarships and incentives.
- It should also organize programs for students' psychological, physical, and future development, including technical, social, and academic activities. The association should invite distinguished alumni to inspire present students through lectures, meetings, and seminars.
- Conduct social gatherings of Alumni during college-day celebrations and on other days.
- Being a helping hand in promoting and encouraging education among the community.
- To plan, organize, arrange meetings, reports, and other projects to stimulate frequent activities.
- Correlating with faculty in teaching, In favor of standardization of scientific techniques, tests, and criteria.
- And to take active part in the establishment of laboratories, libraries, Botanical gardens, museums etc. in the college.
- Provide scholarships and academic prizes to the students of Government College (A), Rajahmundry.
- Perform all other things that are incidental or conducive to achieve the above objectives
- Engage in public charity, to take part in first aid, welfare and relief works in times of natural calamities and crises.

Eligibility for membership

Article: I

Membership: The eligibility is limited to those students who have studied in and shall consist and comprise of the following categories of members.

Life Member: Any old student who studied in Government College (A), Rajahmundry and who pays Rs 1500 / shall be eligible for Life member and shall have voting right and be eligible to contest for executive posts & it is valid for 20 years

General Membership: Any student who will pass out from their graduation/Post graduation have to pay Rs 200 / to get the General Membership and it is valid for only two years & it will be affected from 2023-2024 academic year. (No voting right for General Membership category)

Honorary member:

The principal Government College (A), Rajahmundry shall be the Honorary member without voting right and shall not be eligible for executive post.

The membership subscription shall be kept in a Nationalized Bank.

Any change in the membership fee or qualification of membership made in this article will be effective only from the date of adoption of those articles as amended.

TERMINATION OF MEMBERSHIP

ARTICLE -II

- 1. When any member submits resignation letter**
- 2. Death of the member or the dissolution of the Association.**
- 3. On being declared as insane by the court or a mental hospital.**
- 4. On the recommendation of sub-committee consisting of five persons appointed by the executive committee to enquire into the activities of the member and if found he/ she is acting against the interests of the association and if such sub-committee recommends that the continuation of such member is detrimental to the interest of the association.**

Meeting

AIRTCLE III:

1. The General Body meeting shall be organized once in a year (usually in March) to discuss and approve the resolution and to conduct of Alumni elections for the Executive Committee. The election process, eligibility criteria, and voting procedures will be outlined. All eligible alumni are encouraged to participate and elect the Executive Committee members by casting their votes.

2.General body meeting may also be called at any time at the discretion of the executive committee or by requisition of at least one-tenth of the total voting members.

3.The General body of the association shall consist of all categories of members such as life members, and honorary members.

4.FUNCTIONS OF GENERAL BODY: The ultimate authority in all matters relating to the administration of the association shall rest in the General body. The general body shall not however interfere with the power of the executive committee in respect of matters delegated to in these by laws.

1. The General body shall meet at least once in a year after issuing 15 Clear calendar days' notice under certificate of posting in the month of MARCH or on any extended date as may be decided by the executive committee and such meeting shall be called Annual General Body Meeting and shall transact the following business.

To review the activities of the Association and to scrutinize and accept the accounts of the Association.

To issue suitable instructions to the executive committee of the Association.

To review and approve the audited statements of accounts of the Association and the institutions under its management.

To approve and pass the annual budget of the Association as recommended by the Executive Committee for the following year.

FUNCTIONS OF EXECUTIVE COMMITTEE:

- **Organizing alumni events and reunions**
- **Managing alumni engagement and communication**
- **Fundraising and budget management**
- **Representing the alumni body**
- **Supporting the association's goals and objectives**

1.The Executive committee shall meet as per the need and necessity to carry out the association business and the quorum shall be 3/5 of the member

2. The Executive committee shall elect once in Five years - one President, one Vice-President, One General Secretary, one joint secretary, One Treasurer & 10 members and these posts shall be reserved to local (East Godavari district) life members. But just wanted to clarify, elections will be held only for the posts of President, Vice-President, General Secretary, and Treasurer. The remaining posts will be nominated by the new alumni main body who are efficient and can work well for these posts. voters belong to old students of GCRJY Only who have took life membership only.

3. Executive committee shall have power to add, amend, repeal, or cancel the members to the association from time to time.

4. Any of the clauses of the articles of the Association can be amended by the Executive committee specially called, for that purpose with a majority of 3/5 th members present.

5. The Executive committee shall have power to appoint auditors, legal advisors for the Association and fix their remuneration. They shall hold office till the next annual general body meeting.

6. Executive committee shall have all the powers incidental to carrying on the objects of the Association.

7. The Executive committee shall conduct meeting occasionally and if required the Executive committee proposed the GB meeting.

8. All matters shall be decided by simple majority vote of the members present in case of tie the President shall have to use his vote.

9. Quorum of Executive committee shall be 2/3rd . if there is no quorum for any meeting the same shall stand adjourned to someday next week and there need not be any quorum for it.

EXECUTIVE COMMITTEE

ARTICLE:IV

Over-all management of Association shall vest in the executive committee.

- 1. The executive committee of this Association shall consist of one president, Vice-President, One Secretary, One Joint Secretary, One Treasurer, 10 Members. If these officers change their residence away from East Godavari district, they shall cease to hold that designation and shall continue as members of the association In such an event President shall nominate one of the executive members to hold the post. However, president can nominate those members for the posts of the region to which they hail from if there is a vacancy. In case of contests to any post all life members are eligible to vote.**
- 2. The principal Government College (A), Rajahmundry shall be the EX-Officio Advisor.**
- 3. The immediate outgoing president, vice president, Secretary, and Treasurer shall be the EX-Officio members of the current executive committee, they will have the voting right.**
- 4. The administration and management of the Association and all its properties shall vest on the executive committee of the Association.**
- 5. The executive committee shall have powers to frame rules and regulations for the administration and Management of Educational Institutions of the Association from time to time. These rules and regulations to be ratified, If necessary, by the General Body of the Association in the immediate subsequent meeting.**

6. The executive committee shall have the power to appoint sub-committees from among its members to carry out any specific purposes.

Sub-committees are usually.

- **Sites and Building Sub-Committee.**
- **Finance and Budget Sub-Committee.**
- **Administration Sub-Committee.**
- **Academic Sub-Committee.**

7. Association has to appoint staff and other employees of the Association, fix their emoluments, and to define their duties and conditions of services after Executive committee meeting.

8. President has to punish, suspend or dismiss the members of the staff of the Association subject to such service rules as may be framed in this behalf after Executive committee meeting.

9. To appoint auditor and legal adviser.

10. To institute conduct, defend, compound, or compromise all legal proceedings by or against the Association.

REMOVAL

***Any member of the executive committee or some members or the committee members as a whole may be removed by a resolution in the General Body meeting proposed by a voting member seconded by another voting member and passed by 2/ 3rds majority vote among the members present at the general body meeting provided a notice of the resolution is given at least one month before General Body meeting. The Secretary shall have to circulate the resolution to all the voting members at-least 15 days in advance of the meeting at which final decision is to be taken.**

AMENDMENTS

Article :VI

Any article of this constitution or any provision of the By Laws, may be amended by a three-fifth vote of the voting members present at any Executive committee meeting, provided that copies of each proposed amendment shall have been circulated to all members at-least 15 days in advance of the meeting at which final decision is to be taken, and confirmed by two- thirds of the members present at a special meeting convened for the purpose after an interval of one month from the previous meeting.

FELICITATIONS

Teachers: The principal of Government College (A), Rajamahendray and the teachers who worked and or retired from this institution may be felicitated on the reunion days . They will be presented with a shawl, a memento, and a certificate.

Students: The students who were Graduated and post Graduated from this institution, and who are life members.

1. Those who attained higher position in public figure or in private service.
2. Those who are politically active and have successful political career.
3. Those who are successful in Literary Activities.
4. Those who are successful in professional activities and attained 60 years of age.
5. Those who are successful in sports and other extracurricular activities.
6. Such persons may be felicitated and presented with a certificate & a memento
7. The association shall not make any profit or award bonus to any of its members. It may award prizes to individuals.

CERTIFICATES

BYLAWS

Chapter I - Memberships

Section 1:

There shall be three classes of membership in the Association.

1. Life Membership (1500 rs):

Old students, who have studied in Govt. College, Rajahmundry, and this group shall have voting right and it is valid for 20 years.

2. Honorary Membership:

The principal, Govt. Arts College Old Students Association”, Rajahmundry.

3. General Membership (200 rs):

**Any student who will pass out from their graduation/Post graduation shall pay & get the General Membership and it is valid for only two years.
(No voting right for General Membership category)**

Section 2: All applications in prescribed form shall be submitted to the Secretary, who will place them before the next meeting of the executive committee which will take decision regarding admission of membership.

Chapter II:

Section 4:

- The Alumni Association is a voluntary service organization to do college development programs and social activities

Alumni Association consists of one President, one Vice President, one General secretary, one joint secretary, one Treasurer and 10 members. But just wanted to clarify, elections will be held only for the posts of President, Vice-President, General Secretary, and Treasurer. The remaining posts will be nominated by the new alumni main body who are efficient and can work well for these posts. voters belong to old students of GCRJY Only who have took life membership only.

- The term of the newly elected committee is 5 years. After completing one term, individuals who have served in key positions are also eligible to contest again.
- After the term of an Alumni Association committee member ends, an election notification will be issued on March 31 to elect a new alumni body.
- Candidates for key positions like president, vice president, General Secretary, and Treasurer must be at least 35 years old to participate Alumni Election.
- Nomination fee for president post rs 20,000 (NON REFUNDABLE). This amount should be utilized solely for election expenses and alumni activities. This amount is fixed by the approval of the Executive committee.
- No Life membership will be issued to any old student of GCRJY from one month before Alumni Election.
- After the term of the Government Arts College Alumni Association ends, the association must continue under the same registration number, and no other alumni members are allowed to form a separate alumni association.
- The name, Logo, goodwill, and official recognition of this association shall not be misused.
- Life membership: 1500/-

Only those who have taken a ₹1,500 life membership will have the right to vote and the members belongs to who have studied in Government College (A) Rajahmundry.

VOTING RIGHTS: - (SPECIAL CATEGORY)

The following categories having voting right without Life membership.

1. Alumni who are working in Govt (A) Collage as Regular, Contract or guest faculty at the time of Alumni new body Election.
2. Alumni who contribute to construct buildings or infrastructure of the college.
3. Alumni who served as M.P, MLA, MLC & Bank Directors
4. Alumni with minimum 10 years professional experience in MNC's or pharmaceuticals or Reputed organizations or software sector.
5. Senior Government officers those who have minimum 10 years' experience and celebrities in the field of art.
6. Former students (Old Students) who are running voluntary organizations and have voluntarily supported Alumni activities in the past, resolved institutional issues, as well as media representatives who have contributed to the development of the college, shall be granted the right to vote, even without holding a Permanent Membership Number, in recognition of their services.
7. The administration, direction & management of the affairs of the Association shall be entrusted to the executive committee consisting of one President, one Vice President, one secretary, one Joint Secretary, one Treasurer and ten members.
8. These members shall be elected at the Annual General Body Meeting (MARCH) and shall hold office for five years or until their successors assume office.
9. The executive committee shall be elected by the members having the voting right & Only Life Members are eligible to elect the Alumni Association. Executive committee members can be elected for any number of terms
 - a. The recognition of the association without the permission of the College Principal is invalid.
 - b. The sanctioned association can take legal and disciplinary action against any other association formed without the permission of the College Principal.

c. Legal proceedings of the association shall be within the jurisdiction of Rajahmundry city only.

ie:- 1. Complaints against the Association.

2. Complaints made by the Association.

d. Not more than one of the offices of president, Vice-president, secretary, or Treasurer shall be held by the same individuals.

(No member should hold more than one executive post)

e. The quorum of the executive committee shall consist of five members and any resolution of the committee shall not be passed unless the motion shall have atleast four asserting votes.

f. If the president is absent from Rajahmundry, his powers and duties shall be exercised and performed by the Vice-President present in Rajahmundry.

g. If the Treasurer is absent from Rajahmundry or is on leave, the president may designate a member of the executive committee to exercise the powers and perform the duties of the treasurer.

h. If office of the General secretary becomes vacant, the joint secretary will exercise the powers and perform the duties of Secretary in the absence of Secretary. In case the joint secretary post is vacant, one of the executive members can be designated as Joint Secretary by the President.

i. If the posts of General Secretary and Joint Secretary fall vacant, the president of the Association may designate a member of the executive committee to perform the duties of the Secretary and other member as Joint secretary.

j. The president shall appoint one or more editors as he thinks fit to organize the old students Section in the College Magazine and Journals etc

k. While changing the names of the new members of the body in the registration, 1/2 + (majority) has the option to change

- b. Financial assistance (donation) is provided to the poor students studying in our college for health related and sudden accidents**
- c. Any person having criminal cases, cheating cases, or sexual harassment cases (ladies) are ineligible to contest the Executive posts.**

Section 5: The powers and duties of the executive committee shall be as follows:

- i. To manage the affairs of the association and for such purposes to make such regulations as may to them appear conducive to the good administrator of the association and the attainment of the objects of its foundation; provided always that such regulations be not inconsistent with anything contained in these rules, that they be reported to the next annual general meeting for the information of the members and that they be subject to rescission alternation by the general body meeting.**
- ii. To consider in the first instance, all communications addressed to the academy, to decide which of such communications shall be submitted to a general body meeting and determine the other and manner of such submission.**

To supervise and direct all the publication of Association.

- iii. To appoint as many salaried officers, clerks or servants as they may deem necessary, to define their duties, allowances, salaries gratuities and privileges and to suspend or dismiss them, or dispense with their services as the service as the situation requires and to report all such actions to the next general body meeting.**
- iv. To prepare and submit to the annual general body meeting or report on the general concerns of the academy report shall set forth the income expenditure for financial year of the association, the balance in hand, the debt and assiette estimated income and expenditure of the succeeding year and the general progress of the association. The report shall also include an abstract of the proceedings of the executive committee during the year.**

v. In conformity with the provisions of the Registration Act No. 35/2001 /section 24 & 25 under which the Association has been registered, the executive committee shall be empowered subject to the sanction an ordinary general meeting, to leave legal proceedings under the Act for recovery of any sums due from a member on account of subscription, books manuscripts or any other property of the Association in case any member after receiving due notice of his liabilities, shall refuse or fail to discharge them.

vi. To arrange for the establishment of reciprocal relations between the Association and other learned bodies in India.

v. To constitute and control such administrative and specialist committee as may be required to facilitate the work of the academy. Such committee may constitute sub-committees.

Section - 6: powers and Duties of the President:

- 1. To preside over all meetings of the Association and of the executive committee and to regulate the proceedings of such meetings.**
- 2. To ensure due effect being given to the rules of Association and to the regulations made by the executive committee under section (a)**
- 3. To supervise overall the affairs of the Association.**
- 4. The President shall be the legal custodian of the Association. He/ She can sue or can be sued. Rajahmundry shall be the legal jurisdiction of the Association.**
- 5. If any member of the Alumni committee does not cooperate to the Association, then president of the Alumni association may conduct a meeting, prepare resolution and remove them.**

Section 7: Duties of the Vice President:

In the absence of President, the Vice-President shall preside over the meetings of the General Body and Executive Committee and Perform all the duties of the President.

Section 8: Duties of the General Secretary:

- 1. To conduct correspondence of the Association and to sign letters and papers concerning the Association.**
- 2. To attend the meetings of the Association and of the executive committee; to keep a record of the proceedings of such meetings during their progress; and at the commencement of every such meeting, to read out the minutes of the previous meetings unless they are taken as read with the consent of the President.**
- 3. To prepare for submission to the annual general body meeting a list of the members, corrected to the end of the previous year.**
- 4. To enter or cause to be entered, in the minutes book all the proceedings of the Association and of the executive committee before the following meeting and to see that all letters and papers and documents of every kind connected with the business of the Association are properly filed and preserved.**
- 5. To be Ex-officio member of the committees appointed by the executive committee.**
- 6. President, General Secretary along with the Treasure shall jointly operate all the bank transactions.**

Section 9: Duties of Joint Secretary.

In the absence of General Secretary, the joint Secretary shall perform all the duties of the Secretary and will function as Secretary.

Section 10: Duties of the Treasurer:

- 1. To receive and hold for the use of the Association, all moneys paid to the Association. He shall disburse all sums due from the Association and shall keep exact accounts of all such receipt and payments.**
- 2. To be responsible for the preparation of the annual statement of accounts and of the budget and for the presentation thereof to the executive committee.**

Sections 11: Duties of the Executive Members:

The Executive Members will be in charges of Cultural, Sports, and scientific activities and to enrol new members, and to co- operate with the General Secretary and treasurer in other matters pertaining to the association.

Sections 12: Meetings of the association

General Body of the Association shall be of two kinds namely

- Annual General Body Meeting.**
- Extraordinary General Body Meeting.**

The executive committee shall meet ordinarily once in three months. Secretary shall issue notices of meeting with the approval of the President. The meeting may also be called by a requisition of atleast five members of the executive committee.

Section 13: All officers shall be elected at the Annual General Body Meeting or at extraordinary general body meeting in case of resignation of the executive body and shall assume office immediately thereafter.

Section 14: Social functions and the business sessions of the Association shall be open to all the members.

FUNDS AND EXPENCES

Section 15

- Funds for meeting the expenses of the academy shall be raised by subscriptions and donations. No financial obligations of the Association, however small, may be incurred by any one or group of members, except upon prior authorization of the executive committee and disbursement by the treasurer may be made only upon prior authorization of the executive committee except in emergency which will be decided by the executive committee.
- Life membership subscription & membership will be spent for day-to day administration.
- The funds received through membership fees (LMB/GMB)) and donations shall be utilized for the following purposes:
 - - Daily administrative activities of the Alumni Association
 - - Arrangements for platforms and felicitations during special events
 - - Student welfare activities
 - - Incentive awards for students
 - - Assistance to poor students
 - - Resolving student issues (transportation, food, refreshments)
 - - Hospitality for distinguished alumni
 - - Infrastructure development (room construction, road construction, drinking water facilities)
 - - Media arrangements, pamphlets, flexes, stickers for publicity
 - - Organizing yoga, aerobics, sports competitions and runs for student health development.
- The funds shall be spent only for the achieving the objects of the Association and no portion thereof shall be paid or transferred either directly or indirectly to any of its members through any means.

Section 15-A: The Bank accounts and fixed deposits and any other financial accounts will be maintained both by the Secretary and Treasurer. When there is a change of persons the signatures of the new office bearers will be duly attested by the president which will be forwarded to the Bank for authorization to maintain the account. The Secretary and Treasurer are held responsible for the accounts in addition to their other duties as mentioned in the Section 8 and 10 of Chapter II.

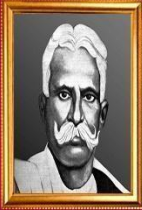

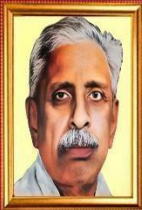
